




Figure 1. Static Characteristic




Figure 2. DC current Gain ( R grade )




Figure 3. DC current Gain ( O grade )




Figure 4. Collector-Emitter Saturation Voltage




Figure 5. Base-Emitter On Voltage




Figure 6. Base-Emitter Saturation Voltage




Figure 7. Thermal Resistance




Figure 8. Safe Operating Area






Figure 9. Power Derating
