






Figure 1. DC Current Gain




Figure 2. Collector-Emitter Saturation Voltage




Figure 3. Base- Emitter Saturation Voltage




Figure 4. Collector- Base Leakage Current




Figure 5. Collector- Base Capacitance





Figure 6. Power Derating
