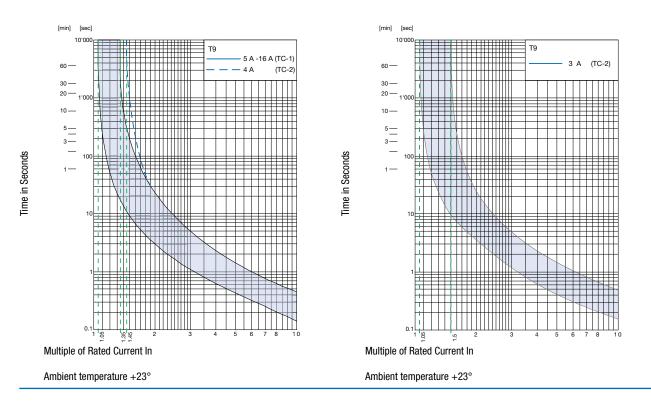

Effect of ambient temperature

The units are calibrated for an ambient temperature of $+23^{\circ}$ C. To determine the rated current for a lower or higher ambient temperature, use a correction factor (typical value) from the table below:

Ambient Temperature [°C]	Correction factor
-5	0,85

+23	1,00
+40	1,08
+60	1,21

Example: Rated current = 10 A, Environmental temperature = 60 °C, --> Correction factor = 1.21, Resulting current = 12.1 A --> Round to next higher rated current: 13 A
