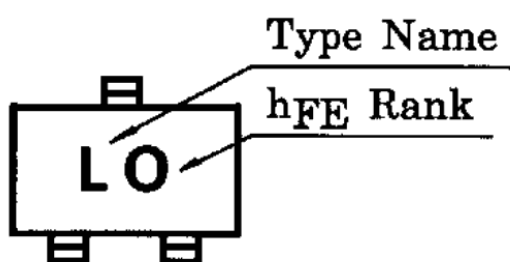

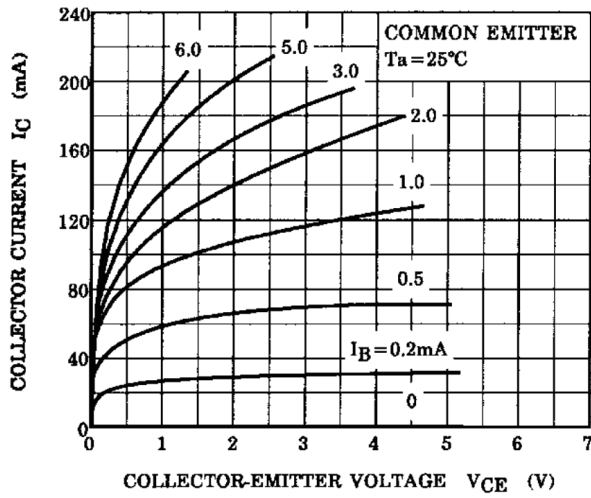


Fig. 8.1 $I_C - V_{CE}$

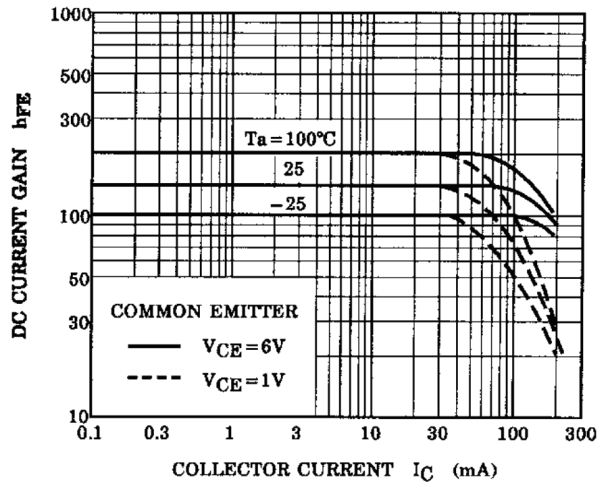


Fig. 8.2 $h_{FE} - I_C$

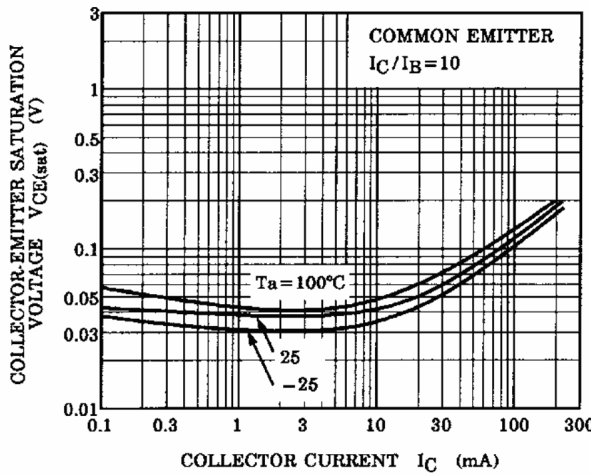


Fig. 8.3 $V_{CE(sat)} - I_C$

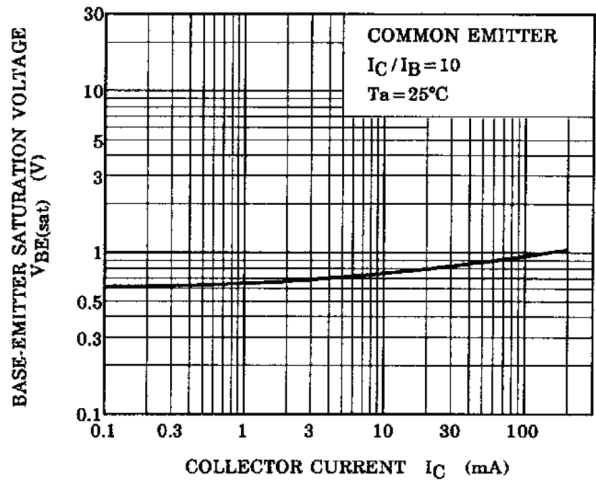


Fig. 8.4 $V_{BE(sat)} - I_C$

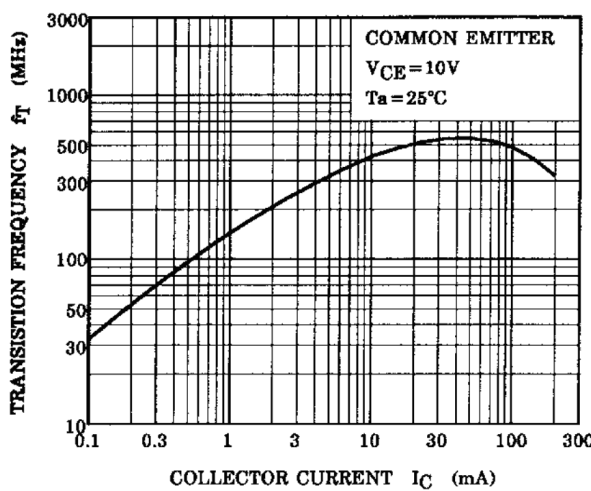


Fig. 8.5 $f_T - I_C$

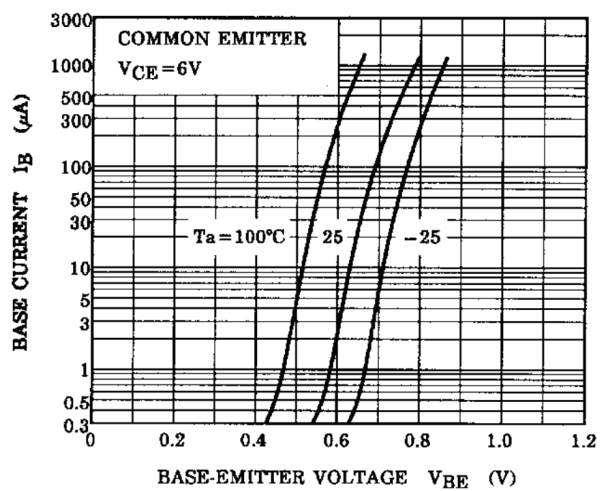


Fig. 8.6 $I_B - V_{BE}$

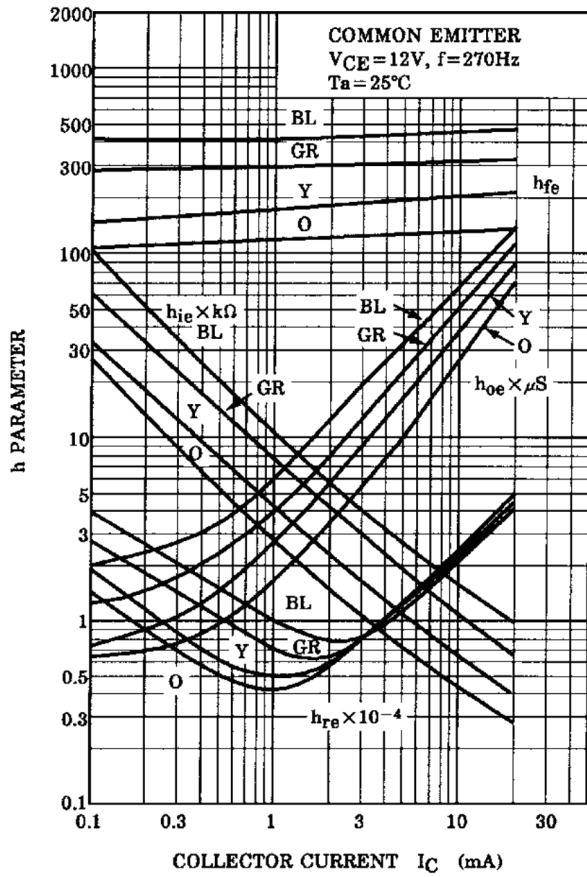


Fig. 8.7 h PARAMETER - I_C

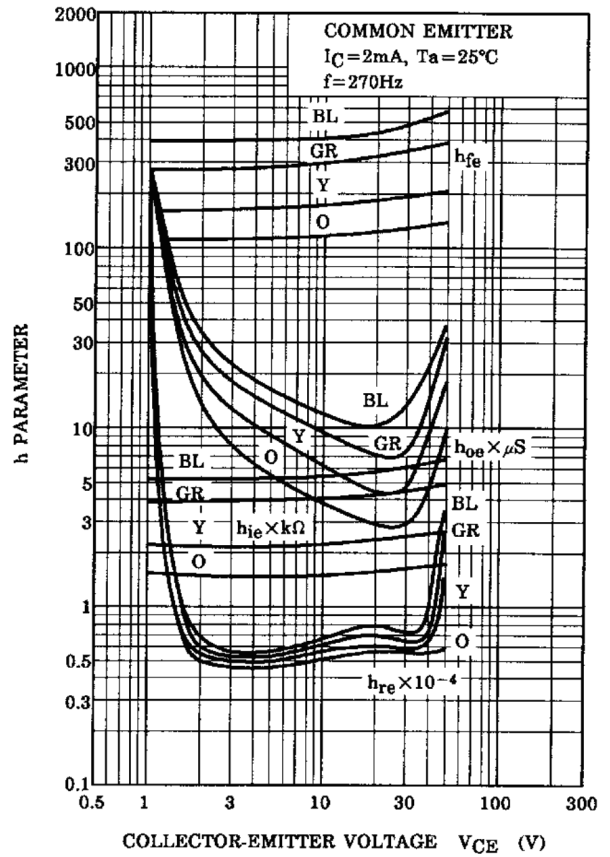


Fig. 8.8 h PARAMETER - V_{CE}

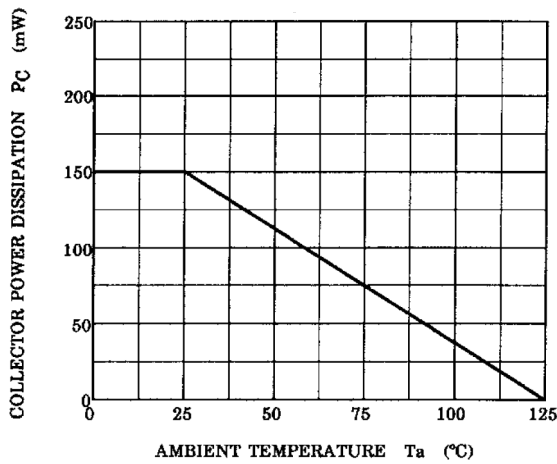


Fig. 8.9 $P_C - T_a$
 Reference only with T_j of $125^\circ C$.

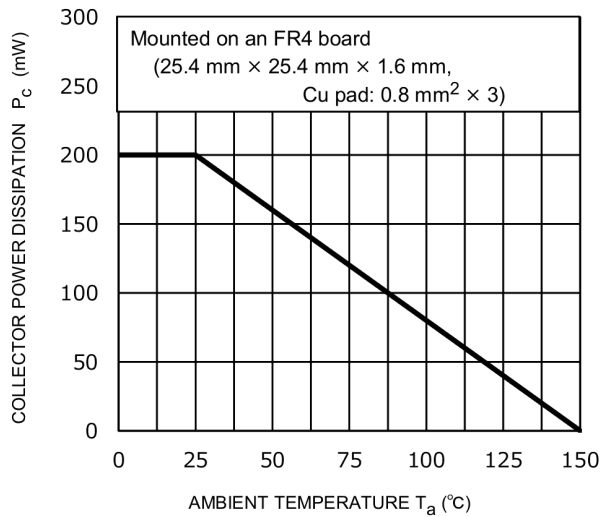
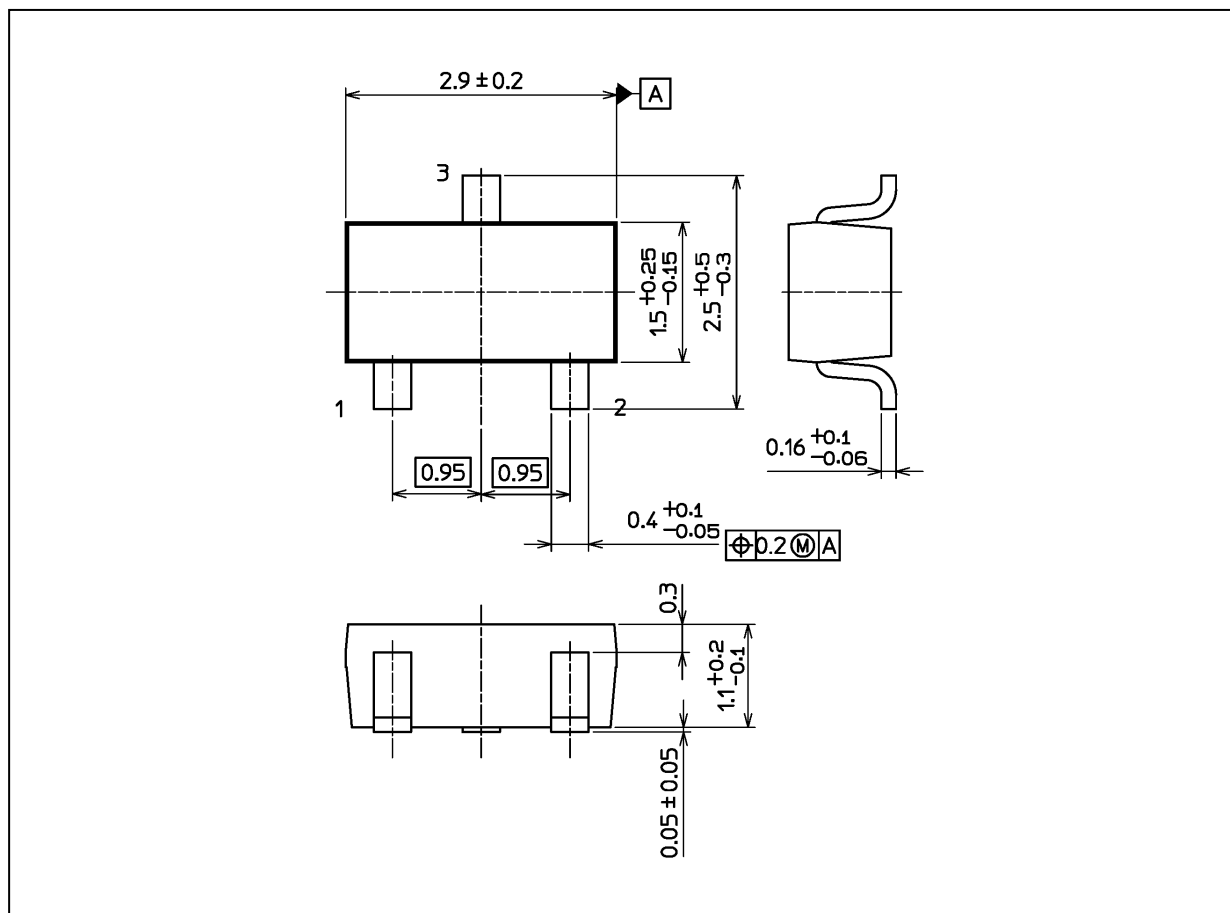


Fig. 8.10 $P_C - T_a$
