



Top View Pin-Out










Figure 1 Typical Collector Current vs. Collector-Emitter Voltage




Figure 3 Typical DC Current Gain vs. Collector Current




Figure 5 Gain-Bandwidth Product vs. Collector Current




Figure 2 Typical Collector Current vs. Collector-Emitter Voltage





Figure 4 Typical Collector-Emitter Saturation Voltage vs. Collector Current


