



Top View Pin-Out






Fig. 1, Max Power Dissipation vs. Ambient Temperature





Fig. 3, Collector-Emitter Saturation Voltage vs. Collector Current






Fig. 2, DC Current Gain vs. Collector Current




Fig. 4, Base Emitter Saturation Voltage vs. Collector Current





Fig. 6, Capacitance vs. Reverse Voltage


