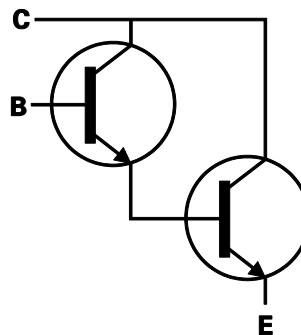

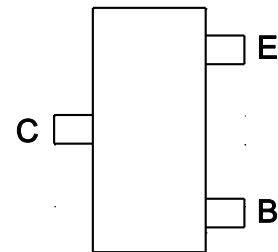

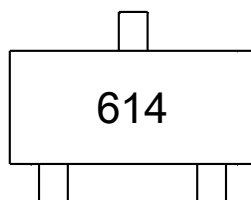
Top View Pin-Out

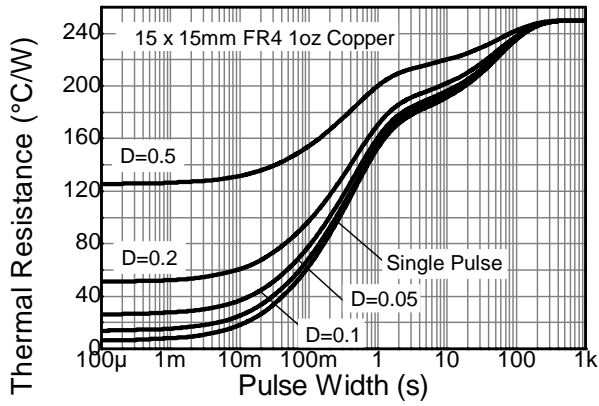

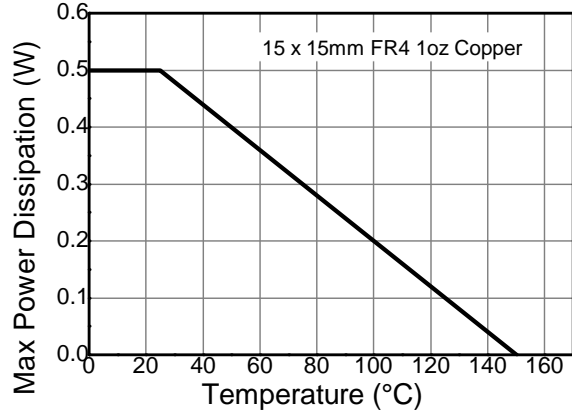

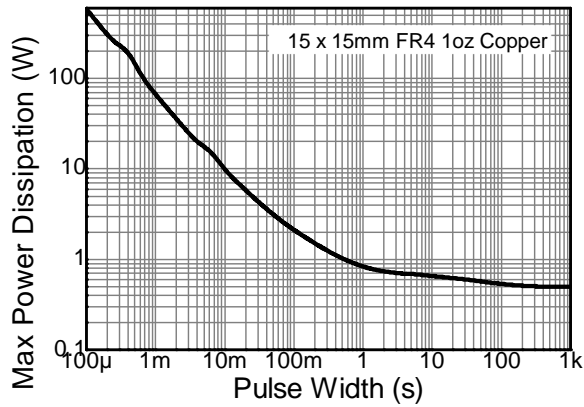
Thermal Characteristics and Derating Information

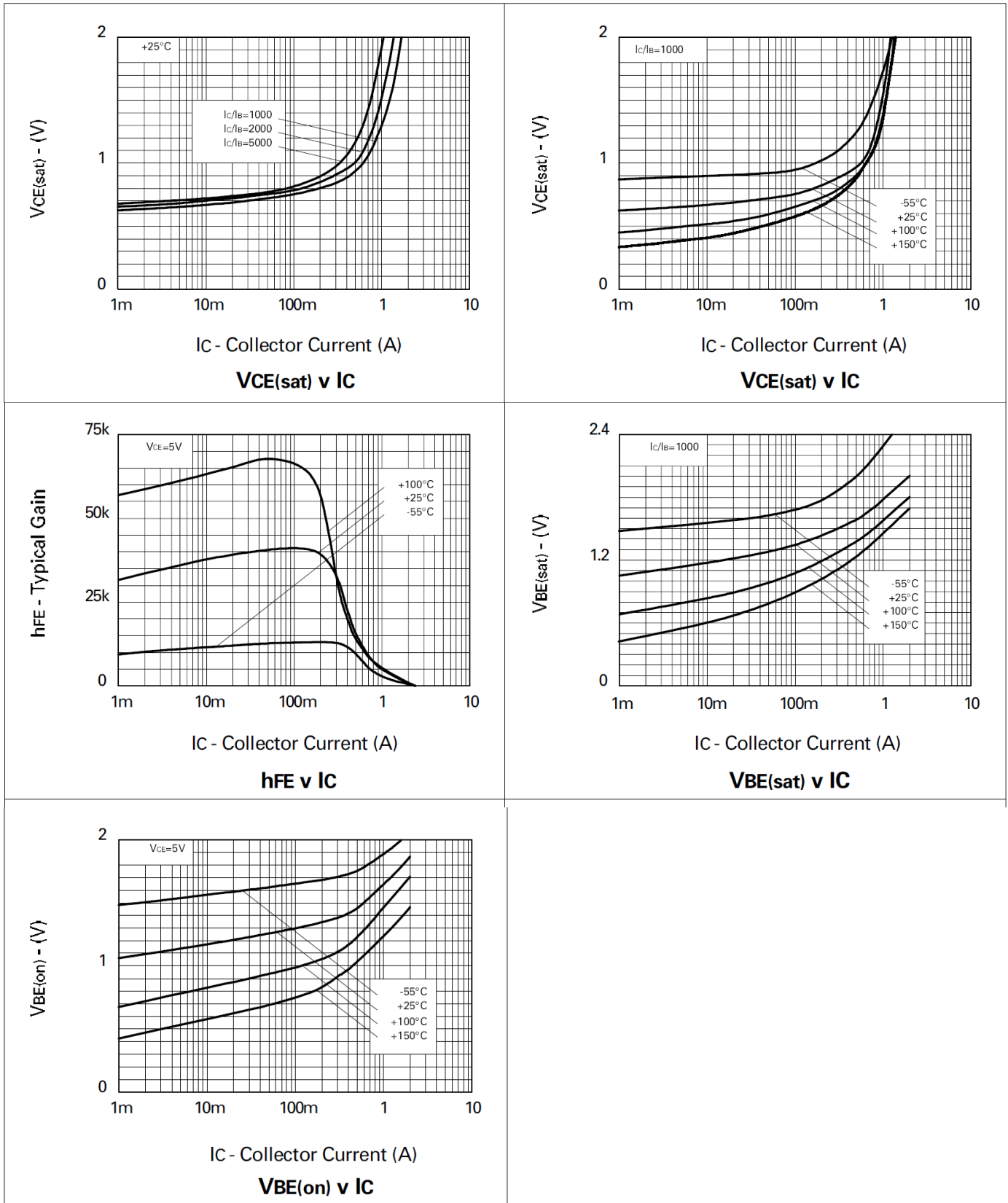

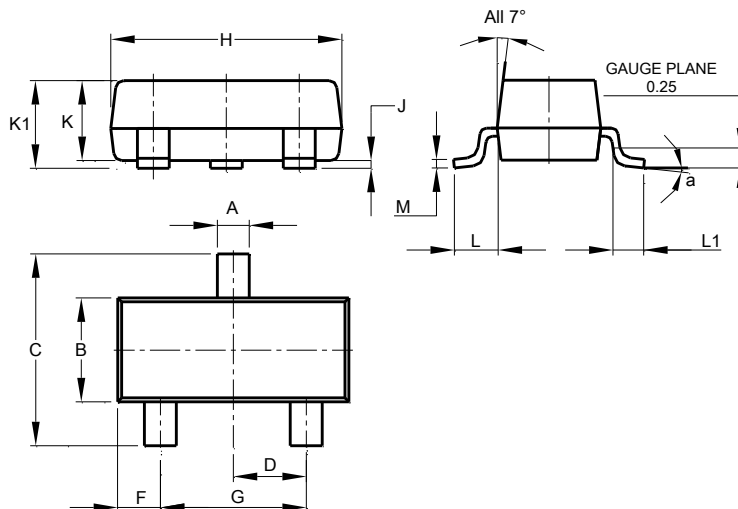

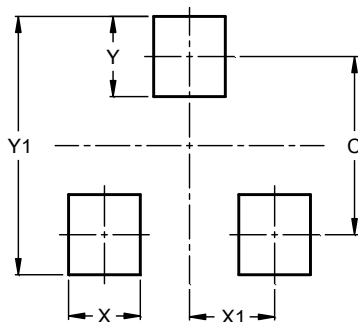
