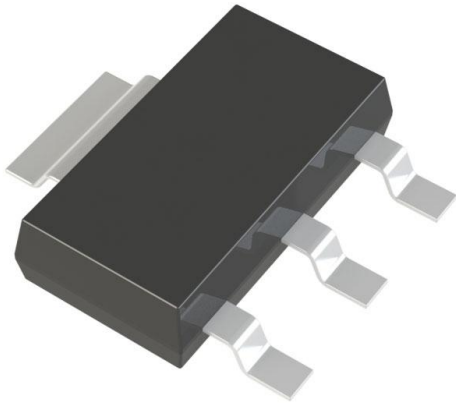

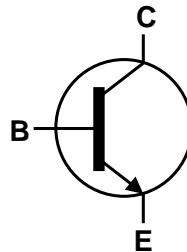

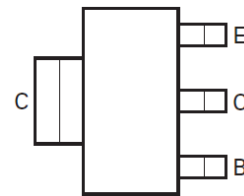

Equivalent Circuit

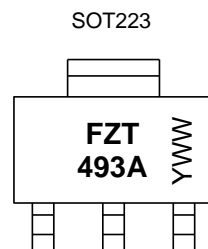
Top View

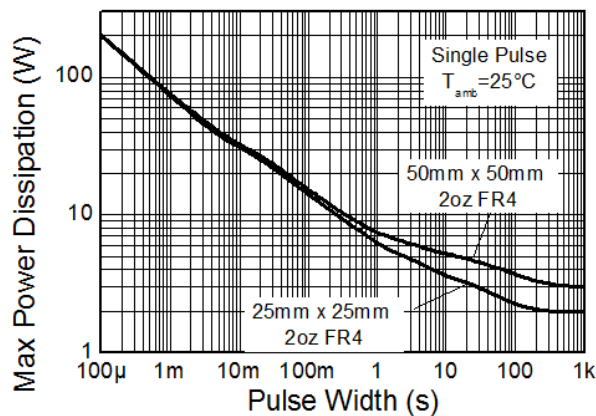
**Safe Operating Area**



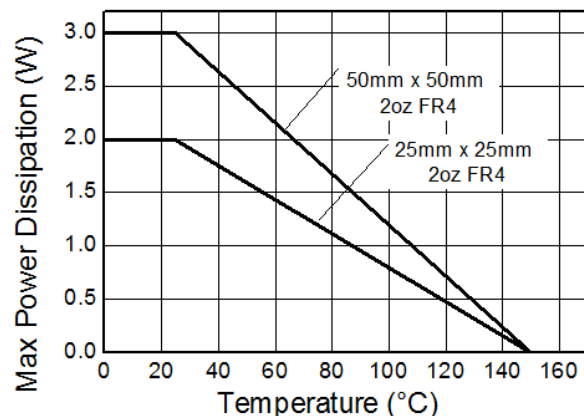
**Transient Thermal Impedance**
